NPCA's principal priorities since the September 27 board meeting included the following:

- Grasstops and grassroots advocacy for a \$410.5 million Peace Corps 2021 budget
- Collaboration with Rep. Garamendi's office on Peace Corps Reauthorization legislation
- Development and publication of the Peace Corps Connect to the Future report
- Preparation of the 2021 annual operating plan and budget, and supporting documents
- Launching of the COVID contact tracing project with King County, WA
- Launching of the social marketing campaign with RPCVs for Environmental Action

MOTION 2: The NPCA Board of Directors resolves to adopt the DE&I Framework as presented and provide provisional oversight through the Programs Committee in development.
