- Preparation of 2019 year-end financial reports and assessments
- Completion of the architectural design and permits for Peace Corps Place

# MOTION: The Board of Directors resolves to acknowledge and appreciate the efforts of NPCA staff for National Days of Action.

### Treasurer's Report - Gretchen Upholt

NPCA's business model is getting more complex, including with an increase in restricted gifts. Gretchen noted that unrestricted revenue has increased over the last few years, as well. The committee is seeking to improve tracking to ensure that financial statements mirror the audited version.

# Fundraising Committee Report - Robert Nolan

Committee is looking at foundation grants and getting a better understanding of what our community's interests are. Committee has identified three categories for fundraising -- individual

giving, foundations/grants (based on results of survey) and sponsorship. Robert said he would like to see board giving increase to \$100,000 annually.

## Governance Committee Report - Chip Levengood

The committee seeks to redefine board roles and responsibilities and will reach out to the community (maybe via webinars or town halls) so they can be more engaged and help them understand how member-elected board members can be more effective. Also, we are looking for candidates for board of directors in the upcoming election.

## <u>Advocacy Advisory Committee Report</u> - Jed Meline MOTION: Resolved that the board of directors adopts the "NPCA Policy Regarding Advocacy Activities," conditional upon review by legal counsel.

<u>Affiliate Group Network Advisory Committee (AGNAC) Report</u> - Anne Baker We are without an affiliate group network coordinator and looking for candidates. Four new groups have joined since January 1, including the first affiliated with a university. We also lost two groups. The AGNAC meeting will be rescheduled.

### New Business - Maricarmen Smith-Martinez

MOTION: The NPCA Board of Directors resolves to designate a bequest, pledged in December 2019 and received in March 2020, to increase the corpus of the Legacy Fund to \$100,000 and to authorize management the discretion to utilize remaining funding for operational expenses.
