#### Call to Order - Joby Taylor, Board Chair

The Board Chair called the Meeting to order at 2:10 PM Eastern Time. A quorum was present.

<u>Introductions</u> – The Chair called on Board Directors, Staff and Guests to introduce themselves. Following the introductions, Board Director Katie Long reprised her song about the Peace Corps experience that she shared at the end of the Walk for Peace earlier in the day.

<u>Minutes Review</u> – The motion by Adams to approve the June 20, 2016 minutes as published in the September 2016 Board Book was seconded and carried.

### **Interim Action by the Board** – Jane Bardon, Secretary

INTERIM MOTION 1: Resolved that the NPCA Board establishes two Annual Advocacy Awards as recommended by the Awards Advisory Committee (Policy 2016008R).

1. The Sam Farr Congressional Leadership Award, which is named for Representative Farr (D-CA and RPCV Colombia 1964-66), who has been a tireless champion of the Peace Corps during his 12 terms in Congress and is retiring this year. One or two awards would be made each year to recognize Members of Congress who have been leaders in legislation and/or appropriations that support our goal of "Helping the Peace Corps Be the Best That It Can Be."

**2.** The NPCA Advocate of the Year Award, which recognizes one or more individuals who have exercised leadership in support of the NPCA's Annual Day of Action, organizing district-level meetings with Members of Congress, and recruiting fellow RPCVs to participate in NPCA's advocacy programs.

### President's Report - Glenn Blumhorst, NPCA President and CEO

# NPCA's principal priorities during the reporting period included:

- Organize Capitol Hill Advocacy Day, Peace Corps Connect and Walk for Peace
- Launch the new website and membership platform (hosted by SilkStart); migrate to new e-newsletter timing and format
- Continue development of Community Fund Case for Support (donor interviews)
- Implement Cultural Agility Leadership Lab (CALL) program with Cigna in Thailand
- Develop reformulated communications plans and strategies

### **Special Items of Note**

- Shriver Circle membership reached approximately 160.
- 2016 Peace Corps Connect paid registrations were about 625.
- Over 250 Advocacy Meetings were held on Capitol Hill with 200 participants.
- 2017 Peace Corps Connect will be held next summer in Denver, Colorado.

## <u>Treasurer/Finance Committee Report</u> – Tony Barclay, Treasurer

**MOTION 5**: Resolved that the NPCA Board of Directors approves the 2015 Audit as recommended by the Finance Committee

**MOTION 6:** Resolved that the NPCA Board of Directors approves an instruction to the Silicon Valley Community Foundation to adjust the portfolio mix of the Global Leaders Fund to achieve a 50/50 mix of Long Term Growth and Social Impact pools.

### **Business and Development Committee Report** – Sandra Bunch, Chair

Bunch encouraged Board Directors to complete the Board Member Action Plan and to host Shriver Circle Dinners to broaden the support of NPCA in their communities. She reported that the 2016 donation from the RPCVs of Wisconsin/Madison was \$6,250; this is 10% of their annual calendar sale proceeds. Wellspring Foundation provided a grant of \$20,000.

# Public Policy and Advocacy Committee Report - Angie Harris, Chair

### Advocacy highlights include:

- The crowd-funding effort raised \$11,320.
- Health Justice Awareness Day included an affiliate group webinar.
- Capitol Hill Advocacy Day on September 22 had 250 NPCA participants and 300 meetings.

### Initial Advocacy Awards awarded at Peace Corps Connect 2016

**2016** Sam Farr Congressional Leadership Award – Representative Kay Granger (R-TX) and Representative Nita Lowey (D-NY) – Granger is Chair and Lowey is the Ranking Member of the US House of Representatives Committee on Appropriations, State, Foreign Operations and Related Programs Subcommittee.

**2016** Advocate of the Year Award – Richard MacIntyre – Richard (RPCV Korea 1967-69) has been a regular presence at advocacy events, both advocating for the Peace Corps and mentoring new participants. In the early years of NPCA's annual National Day of Action, Richard spent dozens of hours volunteering to help prepare and improve our program.

## <u>Membership Committee Report</u> – Joby Taylor, Acting Chair

The Membership Committee did not meet during this period. During the next quarter, with results and data from the website/database rollout, the Committee intends to review the membership model transition in order to provide suggestions from the assessment.

## <u>Peace Corps Connect Advisory and Steering Committee</u> – Glenn Blumhorst, Ex-Officio

Peace Corps Connect 2017 is planned for Denver, Colorado next summer.

### Awards Advisory Committee Report –Tony Barclay, Chair

## **2016 Awards presented at Peace Corps Connect**

Harris Wofford Global Citizen Award – Ibrahima "Bara" Sankare of Mali, Director and founder of Delta Survie, an NGO committed to fighting for the integration of marginalized populations, promoting health and education, developing schools in pastoral villages, and opening centers for women suffering from obstetrical fistula.

Sargent Shriver Award for Distinguished Humanitarian Service – Kevin Fiori and Jenny Schechter (RPCVs Togo), founders of Health through Hope, which delivers efficient, effective, community-driven healthcare in neglected settings such as in Togo.

Loret Miller Ruppe Award for Outstanding Community Service – Friends of Guinea, Friends of Liberia and Friends of Sierra Leone for their outstanding leadership in the Ebola Relief Fund, funding 30 grants to 26 communities in the three affected countries that impacted an estimated 300,000 individuals.
